Repair Costs for Point Pinos Lighthouse, Pacific Grove, California

The below expenses represent work needed on the the Point Pinos Lighthouse in Pacific Grove California. Upon inspection by Trucksis Enterprises Incorporated and an experience Ironworks fabrication company the following has been determined about the existing wood flagpole.

It appears that the pole base at one time has already had repairs for the concrete pad has unmatched areas. The areas are separating. Also, the steel channel irons and their bolts are corroded so that flagpole is no longer supported safely.

It is our recommendation that the concrete footing, 6 ft. Steel channel irons and their bolts be removed. New channel irons and concrete base constructed. Removing bolts on the existing flagpole support, demo and remove concrete footing, fabricate new channel irons support, install flagpole support will total: \$6543.50. This will be titled phase 1.

Phase 2 would consist of fabricating new yardarm support, \$435.00; sanding and repainting flagpole and yardarm, \$600.00; installation of yardarm with new support. During phase 1 it will be determined whether new ball top assembly, ball top, halyard & cleat will be needed. Cost will be provided to you at that time.

If there is a requirement to be named as an Additional Insured for General and/or Professional Liability a \$125.00 fee per each additional insured will be charged. Exclusions from above costs are special permits, fees, special inspections, special paints, shop drawings, hoisting, dry packing, elevations, engineering calculations, unless specified; any penetration through flashing or waterproofing stucco, etc.

-Estimates for flagpole or any installation are only estimates due to unknown underground, install variables. Client agrees to pay any additional installation service fees above and beyond listed above.

-Signee agrees to carry fire, earthquake, liability and other insurance. Signee is responsible and takes full responsibility for the underground variables should any accidents occur. Trucksis Enterprises Inc. And any employee of Trucksis Enterprises Incorporated will be instructed by signee and/or company thereof upon which to dig and will not be held responsible or liable.

-Any alteration or deviation from above specifications involving extra costs or layout changes will be executed ONLY upon written orders, and will become an extra charge over and above the estimate.

-All agreements contingent upon strikes, accidents or delays (weather included) beyond our control.

-50% Deposit is non-refundable due to out-of-pocket expenses for film, screen, equip. rentals, etc.
